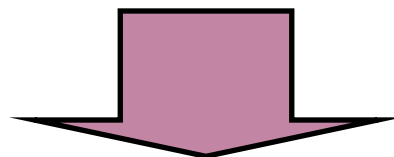

You can submit your WILL, POWER OF ATTORNEY, ADVANCE DIRECTIVES FOR HEALTH CARE WISHES AND GUARDIANSHIP DESIGNATION, to their office and they will give you an unique ID Card/ Member Number for you to carry, in the event you are ever UNCONSCIOUS (for example, ambulance/paramedics, etc.) They can check your wallet and contact the State to get access to these important documents (especially the ones for advanced medical care and who to call in an emergency to make health decisions).
